- *** DECKS, LANDINGS AND PATIOS ARE ALLOWED IN FRONT YARDS PROVIDED THEY MEET ALL REQUIRED FRONT AND SIDE YARD SETBACKS.
- ** DECKS LESS THAN 36" IN HEIGHT SHALL COMPLY WITH THE SETBACK REQUIREMENTS FOR ACCESSORY STRUCTURES.
- ** DECKS OVER 36" IN HEIGHT ABOVE GRADE SHALL COMPLY WITH THE SETBACK REQUIREMENTS FOR PRINCIPAL BUILDINGS.
- ** DECKS LESS THAN 30" IN HEIGHT WILL BE INSPECTED BY THE CITY STAFF.
- ** DECKS AND LANDINGS 30" AND OVER IN HEIGHT ABOVE GRADE MUST BE INSPECTED BY THE CITY BUILDING INSPECTOR. GUARDRAILS MUST BE 36" MINIMUM IN HEIGHT WITH 4" OR LESS HORIZONTAL SPACING BETWEEN VERTICAL SPINDLE MEMBERS.
- ** TERRACES MAY NOT BE MORE THAN 1' IN HEIGHT ABOVE GRADE.
- ** LANDINGS MAY NOT EXCEED 6' IN DEPTH PERPENDICULAR TO THE STRUCTURE OR 8' WIDE AND MUST BE ADJACENT TO AN ENTRY.
- ** RAILINGS, POSTS AND / OR WALLS MUST NOT EXCEED 48" IN HEIGHT ABOVE THE STRUCTURE.
- ** UNCOVERED STEPS AND HANDICAP RAMPS GIVING ACCESS TO THE FIRST FLOOR MAY NOT EXCEED 10' OR CLOSER THAN 5' TO ANY LOT LINE.

The following checklist identifies the minimum requirements for acceptance of an application for a building permit. Should any of the following items not be provided, the application will not be reviewed for approval. The building permit application will not be considered complete until all other required land use permits have been obtained. The building permit review process will commence upon approval of required land use permits. All deck and patio projects must comply with the established zoning requirements. Generally, projects can be plan checked by the city staff within 30 working days after site is flagged and all required documents are turned in to the city office.

The city official will review each box to confirm that each item has been received. Please submit the number of copies indicated for each item requested.
