Ordinance Annexing Territory That Is Inhabited By Less Than Three Voters Or 1s Unoccupied

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF BAYSIDE, REFUGIO COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN THE CITY LIMITS, AND GRANTING TO SAID TERRITORY AND TO ALL FUTURE INHABITANTS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID FUTURE INHABITANTS BY ALL OF THE ACTS AND ORDINANCES OF THE SAID CITY.

WHEREAS, a petition for annexation has been duly signed and acknowledged by each and every person or corporation having an interest in the following described territory, to-wit:

BEGINING at a point the right-of-way of F.M. Highway 136 in the original East line of a road 40 feet wide, for the Northwest corner of said Farm tract 591, the Southwest corner of farm tract 592 and Southwest corner of this tract;

THENCE North with the West line of Farm tract 592 in said Highway right-of-way, a distance of 220 feet to a point for the Southwest corner of share 2 of this partition and the Northwest corner of this tract:

THENCE N.839 25' E., paralled with the South line of share 2, at 20 feet, the East right-of-way line of said highway at a total distance of 1043.9 ft. to a point in the Northwest line of 3rd street of Saint Mary's Addition to Bayside.

AS recorded in envelope 6 of the map records of Refugio County, Texas and the Southeast line of Farm tract 594 for the Southeast corner of share 2 and the Northeast corner of this tract.

THENCE South 48°00'W with the Northwest line of 3rd Street and the Southeast line of Farm tract 594 a distance of 507.5' to a point for the Northeast corner of Farm tract 591, the South corner of Farm tract 594, and the Southeast corner of this tract.

THENCE West with the North line of Farm tract 591 and the Southline of Farm tract 592 and 593 at 639.9' the East Right-of-way line of F.M. Highway 136 at a total distance of 659.9' to the place of beginning containing 5.18 acre of land more or less.

WHEREAS, said tract of land is contiguous and adjacent to the City of Bayside, Texas, and is not more than one-half $(\frac{1}{2})$ mile in width, and

WHEREAS, said petition was presented to the City Council on the 14th day of JANUARY, 1985, such date being not less than 5 and not more than 30 days from the date hereof, and

WHEREAS, after hearing such petition and the arguments for and against the same the City Council has voted to grant such petition and to annex said territory to the City of Bayside, Texas:

NOW THEREFORE, be it ordained by the City Council of the City of <u>Bayside</u>, Texas:

That the above described property be and the same is hereby annexed to the City of <u>Bayside</u>, <u>Refugio</u> County, Texas, be and the same are hereby extended to include the above <u>described territory</u> within the city limits of the City of <u>Bayside</u>, Texas and the same shall hereafter be included within the territorial limits of said city, and said land and the future inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of <u>Bayside</u>, Texas and shall be bound by the acts and ordinances of said city.

The City Clerk is hereby direct file with the County Clerk of Refugio, Texas a certified copy of this ordinance.
