AMENDMENT 34B

AN ORDINANCE AMENDING ORDINANCE 34 OF THE TOWN OF BAYSIDE CITY CODE RELATING TO THE WATER SYSTEM

NOW THEREFORE BE IT ORDAINED by the City Council of the Town of Bayside that Ordinance 34, Town of Bayside, Texas, is hereby amended by adding sections, to be numbered, which said section reads as follows:

- G. 3. All structures intended for human habitation or occupancy, situated on a lot or lots, which lot line is within 200 feet of any public water supply, shall be connected to the public water supply.
 - 4. AUTHORITY TO DISCONNECT UTILITY SERVICES The City Council and/or Building Official shall have the authority to authorize disconnection of utility services to the building, structure or system regulated by the Building Codes, in case of emergency where necessary to eliminate an immediate hazard to life or property or if in violation of city building codes. The city shall notify the owner and occupant of the building, structure or user of the service system, whenever reasonably possible, of the decision to disconnect prior to taking such action. If not notified prior to disconnecting, the owner or occupant of the building, structure or service system shall be notified in writing, as soon as practical thereafter.
- J. 2. Any person violating any provision of this ordinance may be subject to a penalty of up to \$200.00 a day for each violation. Each day any violation of this ordinance shall continue shall constitute a separate offense. However, no penalty shall be greater or less than the penalty provided for the same or similar offense under the laws of the state.
